The Noble Tract is a 261 ± acre recreational and timberland property located in Macon County, Alabama — right in the heart of the state's renowned Black Belt Region, famous for its exceptional wildlife populations and game quality. This property lives up to that reputation, offering an abundance of deer, turkey, waterfowl, and even hogs.

Over the past decade, the land has seen very little human activity, creating a natural sanctuary for wildlife with minimal pressure. The timber on the property is impressively diverse, having grown naturally for more than 35 years. You'll find large stands of upland hardwoods and pine, as well as mature hardwood bottomlands, making this property rich in timber variety and habitat.

The terrain features attractive rolling topography, with elevations ranging from 370 to 290 feet above sea level, adding both beauty and character to the land.

Location is another key asset. The Noble Tract sits almost exactly equidistant between I-85 and U.S. Highway 80 — just over two miles from either major route. From the property, you can reach Downtown Auburn or Montgomery in about 30 minutes, giving you the perfect blend of rural seclusion and urban convenience. Enjoy premier hunting and outdoor recreation with easy access to all the amenities of a nearby town.

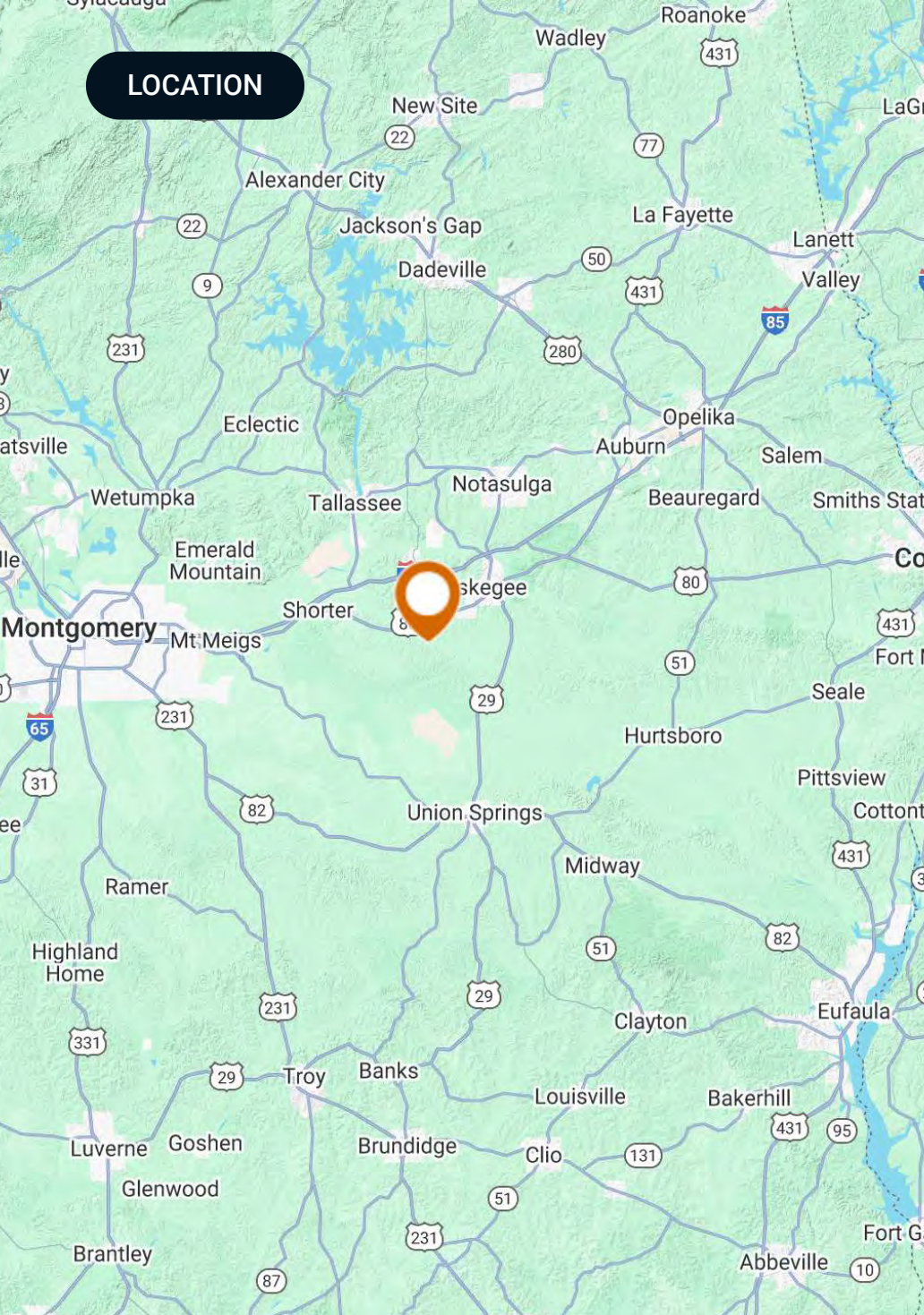

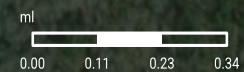

BOUNDARY MAP

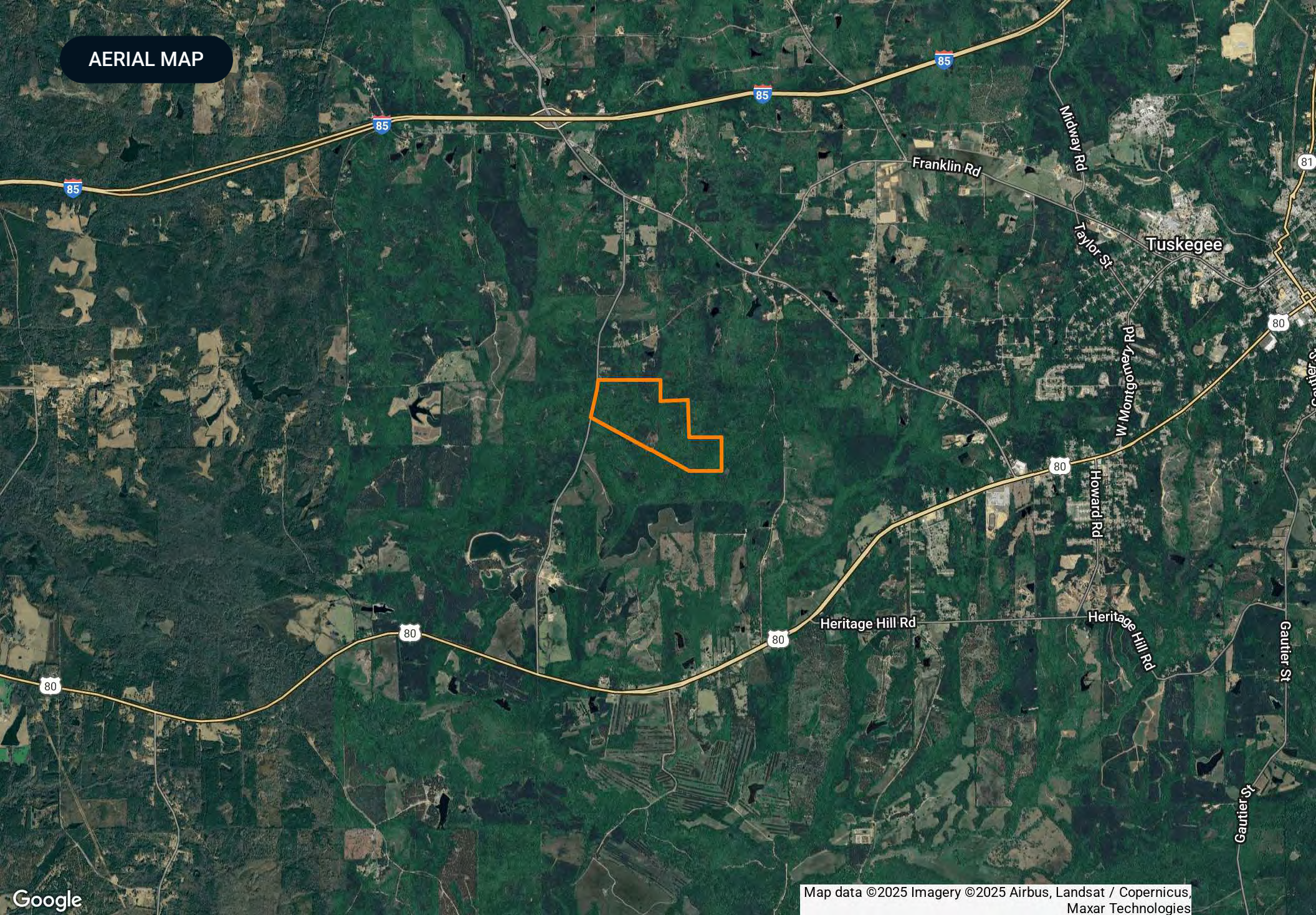

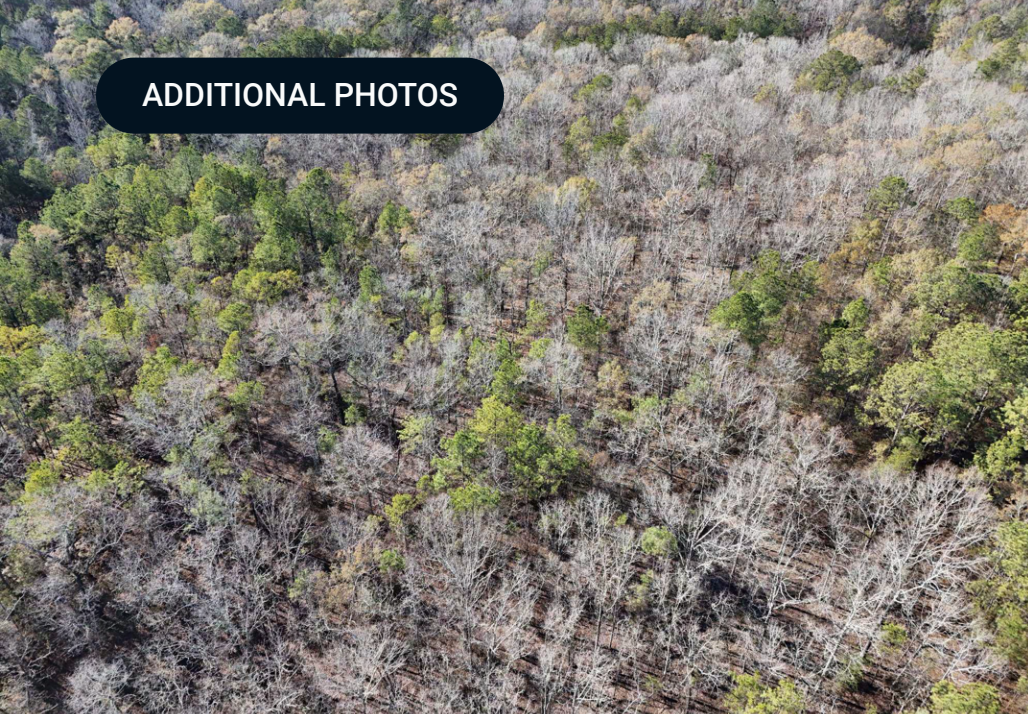
