
The land has a good mix of hardwoods, palmetto, and river sloughs that wind through it. Those sloughs flood at times and create excellent habitat for ducks and other waterfowl. The area also supports a strong population of whitetail deer and turkeys, and it's known locally for good deer genetics.

This Dodge County river tract sits between Hawkinsville and Rhine, Georgia, and has over a mile of frontage along the Ocmulgee River. It's a quiet, secluded property surrounded by large blocks of timberland with a deeded easement for

Currently, the property is covered in beautiful hardwood timber that shades out much of the undergrowth, giving it a clean, open look in many areas. The timber has been purchased by a local company but can be bought back for \$90,000 if the new owner wants to keep it standing.

This tract could also be a good candidate for a conservation easement or WRP program, offering potential long-term value beyond recreation.

With its strong hunting potential and over a mile of river frontage, this property offers the kind of opportunity that rarely comes available in this part of Georgia.
