

## **Kelly Farm and Hunting Land**



Location: Bladen County Highway 53, Kelly, NC 28448 34.4708 -78.2232

Directions: From Wilmington, take Highway 74/76 West for 17 miles to Highway 87 North. Turn right onto Highway 87 and drive 6 miles to Highway 11. Turn right on Highway 11 and drive 8.2 miles to Highway 53. Turn left on Highway 53 and drive 1.3 miles. The farm is on the right.

With two year-round canals adjacent to the fields, providing an easy water source and drainage, the farmland would make an easy to maintain and productive waterfowl impoundment within site of the lowlands along Black River. Beautiful, very mature hardwood and pine timber covers the property that could be harvested for immediate income. There are numerous potential home sites on the farm. Another unique feature is the abundant privacy due to the entire northern border being adjacent to permanently protected land owned by The Nature Conservancy. No deed restrictions, and no HOA!
