

The Yazoo 133 is currently utilized by Denbury Resources, whose pipeline right-of-ways double as well-maintained wildlife plots and internal roadways, keeping access across the property in top condition. A small gravel-bottom creek winds through the land, adding a natural travel corridor and water source for wildlife.

For those looking to build, Yazoo Valley EPA provides electricity, and Central Yazoo Water Association, Inc. supplies community water to the area. Conveniently located just $14\pm$ miles southwest of Yazoo City, $17\pm$ miles northwest of Flora, and only $32\pm$ miles from Madison, this property combines a rural, secluded setting with quick access to town amenities.
